Recording Release Eligibility Period Ends April 30, 2019

Song Recording Must Be Released On or Before April 30, 2019. We encourage new and developing artists who have NOT been previously nominated to participate by submitting a song for nomination consideration.

Please read all Guidelines carefully.

- **A SINGLE ONLY submission does not require membership and is subject to a \$25.00 processing fee as long as it is ONE SONG and/or ONE VIDEO only. FULL LENGTH CDs require an active Advisory membership and a different submission form.**
- **We encourage Native Youth or first time artists still honing their craft to submit a song for nomination consideration in the Single of the Year category.**
- **This is the ONLY category that does not Require Membership, nor a Full length professionally recorded and packaged CD or DVD.**

All eligible recordings must be recorded prior to April 30, 2019 and **not previously nominated** by the Native American Music Awards.

Only homemade CD singles, and videos (non commercially manufactured) will be accepted for the **Single of the Year** category and/or **Best Music Video** category ONLY.

Please ensure your CD or mp3 is correctly titled. **All videos** including those released on social media will be eligible for the video category.

Please enclose Two (2) copies of your single recording for nomination consideration & email us an mp3.

This form does not entitle you membership or permit you to submit more recordings or an entire full-length CD or DVD recording for nomination consideration. Our Full Submission and Membership forms with a paid membership permit for an unlimited amount of full-length CD or DVD recordings.

This recordings should be entered only into the Single of the Year Category or Music Video category and not in any other category.
